

Q. How do I buy tickets?

Tickets can be purchased online through Eventbrite

Tickets can be purchased in-person at:

- Any Ottawa Wallack's Art Supplies locations
- Shenkman Arts Centre, guest services
- Ottawa School of Art locations, Byward Market and Ottawa Campus
- AOE Arts Council

Q. How will I receive my ticket?

A. Your ticket will be emailed to you through EventBrite 5-7 days after your purchase.

Q. What if I don't purchase a ticket through EventBrite, how will I receive my ticket?

A. Tickets will still be emailed to you through EventBrite as all tickets, regardless of pay method, are entered into EventBrite for registration.

Q. Do I have to choose the sessions now?

A. Yes, you must register for the session you want to attend when you buy your ticket. This helps us keep track of how many people are attending each session.

Q. What if I change my mind about which session I want to take?

A. If you change your mind about your session, send an email to info@artpreneurottawa.com with your name and new session selection. We will let you know if there is space to make the change.

Q. What is the cancellation/refund policy?

A. All ticket purchases are final sale. No refunds will be issued.

Q. Will lunch be provided?

A. Yes, a boxed lunch will be provided. It typically consists of a sandwich/wrap, side salad and fruit.

Q. What if I have a dietary restriction?

A. On the registration form, you can opt-in to vegetarian, gluten free or dairy free. All box lunches will be marked so you will know which one is yours.

Q. Does the conference venue, the Shenkman Arts Centre, offer wheelchair accessible seating?
